IMPORTANT: Submit as soon as possible. Applicable aid will not disburse until all items are submitted and reviewed. Once all items are submitted, allow 7 – 10 business days for your complete file to be reviewed.

The California Student Aid Commission (CSAC) requires Student Financial Services to obtain documentation that verifies you have met the following eligibility requirements before you may receive your Transfer Entitlement Cal Grant Award. Your Cal Grant is on HOLD by CSAC for AB840 verification.

Students must meet all of the following eligibility requirements:

- **Graduate from a California high school** (unless military orders required you and your parent/guardian to be out of the state at the time of your graduation) or have completed a high school graduation equivalency (including GED or the California High School Proficiency Exam) on or after June 30, 2000.
- Be a **California resident at the time of your high school graduation**, or its equivalent.
- Earn a verified **community college GPA of at least 2.4**
- Attend and complete at least one term at a CA community college and be transferring to a qualifying CA Institution that offers a bachelor's degree for the 2020-21 school year.
- **Be no more than 27 years of age** by December 31 in the year of first award.

Read the following carefully, then submit this completed form and all requested documents to Student Financial Services as soon as possible. Failure to return this information could adversely affect your ability to receive a Cal Grant award.

1. **Direct Transfer from a California Community College.** In order to confirm you have transferred from an eligible California Community College, Student Financial Services will need a copy of the California Community College Transcripts. Do you allow to Student Financial Services to request a copy of the transcripts you submitted to admissions to satisfy this requirement? (**Select one of the following**).
 - Yes
 - No, I will send a copy of my transcripts directly to Student Financial Services.
2. Please provide Student Financial Services with **one** of the following documents to confirm California residency at the time of high school graduation or on your 18th birthday.
 - A copy of your **California high school transcript** that shows your graduation date, or proof of equivalency. Equivalency may be a passing score for a GED, or a CHSPE by December 31, 2020.
 - A copy of your **parent's** (or legal guardian's) **California Resident Income Tax Return** (Form 540), for the tax year immediately prior to your high school graduation or its equivalent. (For example: if you graduated in 2016, submit a copy of your Parent's 2015 California state tax return).
 - A copy of your CA Driver's License or CA Identification Card for the calendar year immediately prior to your high school graduation or its equivalent
 - Utility bills or mortgage payments for the calendar year immediately prior to your high school graduation or its equivalent

3. Submit a copy of your parent's military records verifying relocation orders from California dated prior to your high school graduation or its equivalent AND at least one of the documents listed above for the period that predates the relocation orders.
