

Guidelines for Spring 2021 Juries

On Monday, Oct. 26, the School of Music Performance Committee met to devise a plan for Fall 2020 juries. In the meeting, many options were presented, and the following guidelines were agreed upon, which will also apply to the Spring 2021 semester:

- Students and studio teachers will decide upon the appropriate repertoire or exercises to be performed.
- An electronic version of the Jury form will be sent to students and studio teachers.
- Students will video record the performance with the following expectations:
 - o No editing should be done
 - o The video should be done in one take, without interruption
 - o No title pages, etc. are necessary
 - o Video length should be no more than 10 minutes
 - o Students may reserve FLPH or the Chapel for recording, but no student workers or SOM staff are available to assist in the recording.
 - o During the recording:
 - § announce your name and major before the first piece
 - § introduce each piece with title and composer
- Accompanists will be available to pre-record accompaniment or record in-person.
- Deadline for submission is April 26, 2021 at 11:00 p.m.
 - o Please allow enough time to produce the video and submit the recording. Late submissions will not be accepted resulting in a failing grade.
